Notes related to the claims verification process for Unibera Developers Private Limited

1 General notes applicable to the overall claims verification process:

1.1 Pursuant to an order dated March 16, 2023 ("**Order**"), the Hon'ble NCLT approved the replacement of Interim Resolution Professional ("**IRP**") and appointed Mr. A. Viswanadha Sarma as the Resolution Professional ("**RP**"), a copy of which was made available to the RP on March 22, 2023.

1.2 There have been certain challenges with regards to verification of claim details with the records of the Corporate Debtor, including but not limited to – access to the updated books of accounts / relevant records etc. Given the state of operations of the Corporate Debtor(s) and ensuing circumstances, it has been the continued endeavor of the RP and the RP team to engage with relevant stakeholders in order to verify the claims in an expeditious manner, as practically feasible, by placing reliance on the Corporate Debtor's records and books of accounts, inputs / information from the Corporate Debtor and the supporting documents submitted by the concerned creditors (including any clarifications, as may have been sought).

1.3 There have been 10 claims (S.No. 643 to 652) included in Annexure 2 as part of creditors in class, for which the delay in submission has been condoned by CoC and thereafter by Hon'ble NCLT on April 12th, 2024 (written order received on April 25th, 2024)
